

# Trent Hills Chamber of Commerce Stay Safe Sweepstakes “Thank you for Making a Difference”

Make an eligible purchase at a participating business located in the Municipality of Trent Hills during the Sweepstakes period and you could win prizes, including a chance for a grand prize of a \$1,000 Trent Hills Shopping Spree. Share your story about why you support local and you could win a prize in the Weekly Draws or the Grand Prize. Total prize pack is a minimum of \$3,500 depending on number of participating businesses.

## There are two ways to enter:

1. Make a purchase at a participating business where your order is curbside, take-out, or delivered (includes electronic delivery). If you receive a gold-prize ticket you are the winner of a gift certificate (value of \$25 or more) from that business, when you contact the Trent Hills Chamber of Commerce to claim your prize. Plus, you will automatically receive 10 entries into the Grand Prize draw.
2. A no-purchase entry may be made by completing a ballot that includes a 25-word testimonial about why you support a local business. Ballots available at [www.buylocaltrenthills.ca](http://www.buylocaltrenthills.ca) You will receive an entry into the weekly draws where two \$25 gift certificate prizes will be drawn at random. One entry, per household, per week during the contest period.

**Grand Prize – A \$1,000 Trent Hills Shopping spree:** A random draw of all eligible entries will take place after the contest period is over. The winner will receive a total of \$1,000 in gift certificates from a combination of up to 20 Trent Hills businesses of their choosing.

1. **SPONSOR AND ADMINISTRATOR** Sponsor: The Trent Hills and District Chamber of Commerce, 51 Grand Road, PO Box 376, Campbellford, Ontario K0L 1L0, 705-653-1551.

2. **SWEEPSTAKES PROMOTION PERIOD** The Sweepstakes begins on Friday January 8 at 12:00 am and ends on Sunday, March 21 at 11:59 pm.

3. **SWEEPSTAKES DRAW** The draw for weekly prizes will take place every Friday at 12 noon, beginning on February 12, 2021 and ending on March, 26. Grand Prize draw will take place March 26 at 12 noon. Odds of winning a Prize depend on the total number of eligible Entries received in accordance with these Official Rules. Participating businesses have been provided with a limited supply of prize-winning tickets, which may not last for the entire duration of the contest.

#### 4. **ELIGIBILITY:**

a) The Sweepstakes is open to all residents of Ontario (excluding Quebec), that have reached the age of majority, except all Staff and Board Members of the Trent Hills Chamber of Commerce and their immediate family members.

B) Participation constitutes entrant's full and unconditional agreement to these Official Rules and the Sponsor's decisions, which, subject to applicable law, are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

c) Sweepstakes entrants are eligible through a duly-authorized with-purchase Gold-Prize ticket or a No Purchase Entry.

#### 5. **ELIGIBLE PURCHASES**

Goods or services, from participating businesses, that are delivered, curbside pick-up, take-out or delivered electronically are eligible purchases. Purchases containing the following goods or services do not qualify as an eligible purchase: alcohol, tobacco, vaping and cannabis products, and lottery tickets.

6. **SWEEPSTAKES PERIOD:** Opens on Friday, January 8 at 12:00 am and closes on Sunday, March 21 at 4 p.m.

#### 7. **HOW TO ENTER**

a) Make a purchase at a participating business where the goods/services are curbside pickup, take-out or delivered to the customer. Digital delivery of services is included.

When you receive the goods or services you purchased and find a Gold-Prize sticker, contact the Chamber to claim your prize.

b) No-purchase entry, one per household per week (Friday to Thursday), may be made with a 25-word testimonial on why you shop/support a local business. No-purchase entry forms will be located on the [www.trenthillsbuylocal.ca](http://www.trenthillsbuylocal.ca) website. Entries must be mailed, delivered or received by the contest closing period.

By participating in the Sweepstakes each Entrant hereby warrants and represents that any materials associated or submitted with their entry (the "Entry Materials"): is/are original to him/her and that the entrant has obtained all necessary rights in and to the Entry Materials for the purposes of entering such Entry Materials in the Contest; does not violate any law, statute, ordinance or regulation; does not contain any reference to or likeness of any identifiable third parties, unless consent has been obtained from all such individuals and their parent/legal guardian if they are under the age of majority in their jurisdiction of residence; will not give rise to any claims whatsoever, including, without limitation, claims of infringement, invasion of privacy or publicity, or infringe on any rights and/or interests of any third party; and is/are not defamatory, trade libelous, pornographic or obscene, and further that it will not contain, depict, include, discuss or involve, without limitation, any of the following: nudity; alcohol/drug consumption or smoking; explicit or graphic sexual activity, or sexual innuendo; crude, vulgar or offensive language and/or symbols; derogatory characterizations of any ethnic, racial, sexual, religious or other groups; that endorses, condones and/or discusses any illegal, inappropriate or risky behaviour or conduct; personal information of individuals; commercial messages, comparisons or solicitations for products or services; any identifiable third party products, trade-marks, brands and/or logos, other than those of Sponsor; conduct or other activities in violation of these Official Rules; and/or any other materials that are or could be considered inappropriate, unsuitable or offensive, all as determined by the Sponsor in its sole and absolute discretion.

The Sponsor or designated content moderator (the "Reviewer") reserves the right to screen all Entry Materials. Any Entry Materials that the Reviewer deems, in its sole and absolute discretion, to violate the terms and conditions set forth in these Official Rules are subject to disqualification. The Reviewer reserves the right, in its sole and absolute discretion at any time and for any reason, to remove any Entry Materials (or any part thereof) and/or to request an entrant to modify, edit and/or re-submit his or her Entry Materials (or any part thereof) in order to ensure that the Entry Materials comply with these Official Rules, or for any other reason. If such an action is necessary at any point during or after the Contest, then the Sponsor reserves the right, in its sole discretion, to take whatever action it deems necessary based on the circumstances – including, without limitation, disqualifying the Entry Materials – to help ensure that the Sweepstakes is being conducted in accordance with the letter and spirit of these Official Rules.

## **8. AWARDING OF PRIZES**

a) The Sweepstakes Sponsor will submit the sweepstakes entrant's name into a random draw of all valid entries received. Any entries that do not meet the rules will be considered invalid.

b) The selected entrant will be required to correctly answer, unaided, a mathematical skill-testing question administered over the telephone at a time mutually convenient to the selected entrant and the Sponsor/Administrator or Sponsor's Agent, in order to be eligible for the prize.

c) The selected entrant may be required to show proof of purchase prior to collecting their prize. Proof of purchase is not required for no-purchase entries.

## **9. PRIZES**

**Estimated value of prizes is \$3,500** (Actual total to be determined by number of participating businesses).

**Gold-prize winner:** The recipient of the gold-prize ticket will receive a \$25 gift certificate from the business where the purchase was made. Each gold-prize winner will automatically receive 10 entries into the Grand Prize Draw.

**Weekly-prize winner:** Each Friday at noon, beginning on January 15 and continuing to March 26, a random draw for a \$50 gift certificate will be made from eligible no-purchase entries made to date. These entries will also be included in the Grand Prize Draw. The weekly prize winners will select their gift certificate from a business in the Municipality of Trent Hills of their choosing. Once a prize winner has been selected for the weekly prize their entry will not go back into the weekly draws, but will remain in the Grand Prize draw.

**Grand Prize:** A random drawing of all eligible entries will be made on Friday, March 26 at 4 pm. A \$1,000 Trent Hills shopping spree will be awarded to one grand prize winner. The winner will receive a total value of \$1,000 in gift certificates/gift cards from up to 20 businesses of their choosing.

## **10. CLAIMING A PRIZE and WINNER NOTIFICATION**

**Gold-prize ticket:** Must be submitted to the Chamber by Monday, March 22 at 4 p.m, meet eligibility requirements and answer a skill-testing question.

### **Weekly draws and Grand Prize draw:**

Each Selected Entrant will be contacted by email or other reasonable means within three (3) business days of the Prize Draw Date. If a Selected Entrant: (a) cannot be reached within five (5) business days of the first notification; (b) fails to correctly answer the skill testing question; (c) cannot provide Proof of Purchase/Payment at the request of the Sponsor (if applicable) or otherwise comply with the Sponsor's verification procedures is determined to be in violation of these Official Rules (all as determined by the Sponsor in its sole and absolute discretion), then he/she will be disqualified and another Entrant will be randomly selected until such time as contact is made by email or other reasonable means with a Selected Entrant (in which case the foregoing provisions of this section shall apply to such newly Selected Entrant) or there are no more eligible Entries, whichever comes first. The Sponsor will not be responsible for failed attempts to contact a Selected Entrant.
